

LIABILITY RELEASE, COVENANT NOT TO SUE AND HOLD HARMLESS (2 Pages)

Warning and Risks

Firearm training, by its very nature and content, is an inherently dangerous activity, and firearms and ammunition, if not handled correctly and safely, or if handled criminally or negligently, can cause property damage, serious bodily injury, and death. Further, firearm training, even when conducted by competent and trained instructors, also involves risks, intentionally or accidentally, from you, other students, the firearm and ammunition being used, and from physical activity, exertion, environmental exposure, and natural (insect or animal) exposure. Further, the actions and actual or clandestine intent of participants in this class cannot be truly known in advance by the instructor or training organization, and participant behavior, actions or competency, is therefore beyond the instructor or training organization's knowledge and control.

In consideration for participation in this training course, I acknowledge the aforementioned risks, and agree as follows:

- 1. I acknowledge that I have read the above Warnings and Risks, and with full knowledge of such risks, I voluntarily agree to participate in the training course, and I assume all risks, whether known or unknown, foreseen or unforeseen.
- 2. Intending that this form be legally binding upon me, my heirs, executors, administrators, and assigns, I hereby waive, release, and forever discharge the instructor, HomeFront Defense & Security, its partners, owners, agents, directors and employees, and third-party facilities, of and from any and all claims, demands, rights and causes of action of whatsoever kind and nature, arising from, and by reason of any and all known and unknown physical and mental injuries, damages or loss, and consequences thereof, whether foreseen or unforeseen, suffered by me from any and all activities during the training class, including any firearm and ammunition-related damages. I specifically waive any statutory rights I may have regarding the release of known or unknown claims.
- 3. I further agree that neither I nor my heirs, estate, personal representative, nor any other person or entity will ever institute any action, litigation or suit at law or in equity against the instructor, HomeFront Defense & Security, and all of its partners, owners, agents, directors and employees, or third-party facilities, for any damages, costs, loss or injury arising out of any and all activities during the training class, including firearm-related activity.



- 4. I further agree to indemnify and save harmless the instructor, all of its agents, directors and employees, and third-party facilities from all liability, loss, costs and obligation of any and every kind on account of or arising out of any injuries or losses incurred by me, however occurring, arising out of any and all activities during the training class, including those directly or indirectly related to firearm training.
- 5. In signing this form, I agree that I have read and understand this entire form; I affirm that I am not under the influence of any substance or intoxicant, and that I am fully competent to agree to, sign, and be bound by this form; I understand that it is a promise not to sue and a release and indemnity for all claims; I further understand that by signing this form I am giving up certain legal rights including the right to recover damages in case of injury; and I agree to abide by the terms and conditions of this form.
- 6. This release does not release any rights I may have under Workers' Compensation Laws. I waive any Workers' Compensation subrogation rights against HomeFront Defense & Security. I agree that any recoveries under Workers' Compensation Laws do not change, extend or enlarge the waivers and protections inherent in this agreement.
- 7. In addition, by signing below, I also affirm that I am not prohibited from possessing firearms or ammunition by any state or federal laws.
